Abstract

The present research study seeks to find out how language is employed by University leaders to build institutional image, express power and influence the reactions of the audience. The researchers engage in a Critical Discourse Analysis (CDA) of the messages provided by the Vice Chancellors of five public and private Universities in Multan, Pakistan. Thus, within the context of analyzing these messages, this study utilizes the model developed by Fairclough in the speeches published for the students who served as the speeches' audience. The target population of this study involves the vice-chancellors of the five different public and private universities present in Multan. These messages were extracted from the respective university official website which are posted to inform students about various programs offered by the universities and various guidelines in relation to admission. Thus, examining the operative of power, authority and institutional discourse, this research enlightens the reader '(how and where)' the educational narratives are constructed in socio-political landscapes of Pakistan. This analysis advances the knowledge of discourse in higher education leadership, particularly revealing how university administrators employ language to navigate their organizations' image and impact stakeholders. The outcome of the present study can help in the identification of discrete linguistic behaviors of the public and private university in Pakistan.

1. Introduction

The main aim of this research is to evaluate Critical Discourse Analysis of different messages of vice-chancellors of public and private universities. Using critical discourse analysis, the researcher sought to shed light on the Vice Chancellors speech's language, power dynamics, and ideology, as well as the speaker's personal experiences as a public speaker. Thus, the use of language, power, and ideology may be observed concerning the current social situation and the social power that is trying to influence the ideology of the community in order to achieve the speaker's goal.

Using critical discourse analysis, the researchers sought to shed light on the vice chancellors 'speeches' language, power dynamics, and ideology, as well as the speaker's personal experiences as a public speaker. Thereby, this research aims to study different speeches of different vice-chancellors to decode the projection and meaning and, above all, how it changes students' way they think and perceive their personal and academic lives in the light of those speeches. Packed with their experiences and intellectual wisdom, Vice-chancellors can be role models for many students. This phenomenon can be significant in determining how quickly students can be influenced by those messages.



1.1 Significance of this Research

This study aims at investigating the manner in which teachers of higher ranks influence students through language. The present study can be therefore be deemed important in that it provides a clear distinction between the everyday use of language as opposed to the way academicians use language to convince students to elicit motivation. Depending on their ideology, the students decode the speeches from the vice-chancellor on different levels and decide on their future courses of action, defining what it means to be a student, the place of their institute in their lives, and rational decision-making capabilities in their academic lives. This research is significant in many ways since it follows, analyzes and tries to explain linguistic abilities that those vice-chancellors possess in their knowledge and how the intended meaning is constructed and delivered and projected through speeches.

1.2 Objectives of the Study

- 1. To familiarize with the structure of the persuasive language towards the learners.
- 2. To identify the overtones of some interlocutor's statements.
- 3. To know the language structure of persuasive language towards students.

1.3 Problem Statement

The present study contributes to filling the identified methodological gap in researching the impact of various approaches to language by comparing how a specific type of discourse can affect the learner differently, while ideology is reflected in the text. The issue arises from how language has been constructed and employed and how different user s' languages tell not only the speaker, language, and power over the addressed/foreseen individual. Selecting the language construct might pose a lot of confusion to the speaker. This research used Critical Discourse Analysis to find the solution to the problem mentioned above of decoding the messages of vice-chancellors of sixteen universities. This research can contribute to students' understating of the message in drawing the meaning, which can be helpful for them in their future academic and professional endeavors.

2. Literature Review

Salayo and Dayo (2020) focused on "Women's Rights and its critical discourse analysis in the speech of Trump." It is clear that power and political ideologies are the main interest of politics. It is mandatory to reveal linguistic features in the speeches which they address to the nation. The approach used in this research was the transitivity system which proved very successful in the analysis of Trump's Speech. In his speech, transitivity processes were revealed, and how these transitivity processes were assimilated was explained. Results showed that about 126 transitivity processes were prominent mentally, relationally, and materially. Material processes gave attempt the protection of human life. Relational processes were constructed for the ideas of life protection. On the other hand, mental processes protected the dignity of life in Trump's speech. It was revealed by transitivity processes that there was very little involvement of women in speech of Trump. (Salayo & D., 2020).



In 2018, Mullet and Diana R. conducted research on Critical Discourse Analysis. It is an approach that assists in the interpretation of a text. Critical Discourse Analysis is simply a methodology in which a text is elucidated. This approach is advantageous in such a way that discourse is studied using this interdisciplinary approach. CDA concerning theoretical perspectives has used different approaches. The approach used in this research was a qualitative analytical approach which is useful for describing discourse. This approach provides different ways to construct a discourse and to bring balance to social inequalities. Thus, it presented a general analytical framework for CDA, which is necessary for providing systematic research in education (Mullet, 2018).

Tinashe, Sonia, and Junaidi (2019) investigated on the Critical Discourse Analysis of Obama and Trump's Speeches". The approach used in this research was the Fairclough model of Critical Discourse Analysis (three-dimensional framework). For this purpose, there were five speeches by Obama, and two speeches by Trump were analyzed. Results showed that their ideology of immigration was the same as that of immigration identity in the society of America. It was seen that diction, pejorative adjective, and different themes were present in presidents' speeches. As far as the political discourse of these speeches was concerned, they had dominant superiority over immigrants. (Tinshe, S., Junaidi, & J., 2019).

In 2022, Ali and Rashid researched positive discourse analysis of the speech given by President Xi Jinping' Speech. He gave this speech at Pakistan's National Assembly. The main aim of this research is to discuss Corpus-based positive discourse analysis. It must be clear that adjectives were examined from a positive discourse analysis perspective and were related to lexical items. In addition to this, three resources were used to examine Xi's speech: the system of engagement system of attitude, and the third one was the system of graduation. Results revealed that many positive resources were present in the speech of the President. It was concluded that language was used in the speech in which engagement was increased (Ali, A., Rashid, A., Ahmed, & M., 2022).

3. Research Methodology

The present research contributes to the existing body of knowledge by concentrating on and analyzing speech in terms of linguistic options, discursive practices, and socio-cultural points of view. It also examines how specific linguistic structures assist speakers in efficiently propagating their beliefs and convincing others to accept those ideologies enthusiastically. The participants in this study are the vice-chancellors of the five different public and private universities in Multan. These messages were taken from the university websites, which were published to help students take information regarding university programs and guidelines regarding admissions. The language used here is intended to persuade young students because young students are the audience that institutions want to attract in the first place. For the purpose of persuading students, persuasive incentives and words such as "guarantee" and "employment" are utilized. Students may be tempted to take advantage of the message's significant influence on the reader because it mentions the worldwide universities of "The United States, Venezuela, and Nepal" and connects those universities with the natives of those countries. Any critical analysis of discourse should pay close attention to the speaker's manner of expression. There is a strong connection between the values of expression and those of relationships and this speech analysis. The expressive value refers to the extent to which the speaker is able to convey their own personal experiences. Analysis of Genre is a term that refers to analyzing a text in relation to the lexical choices utilized in this speech within a broader sociocultural framework.

In addition to this, it can also relate to the specific recognition of patterns in the speaker's speech. The speech makes reference to the underlying meaning and purpose, which is to convince the audience, which consists of the pupils. The author of the message displays discursive conduct, which is constantly shifting throughout the course of the discussion. While the language description is also highly persuasive to, persuade the minds of the people, particularly the students concerned with their own growth, it is particularly effective in influencing the learners. By adding credibility to the ideology and discourse through the use of new terms, the language is used to indicate to students that the university possesses a high status. In order to maximize the possibility that students would be persuaded, the vocabulary used to describe the faculty is intended to reassure students that the university has access to the best faculty possible. By employing the word "dream," students are made to believe they are now enrolled in the nation's best institution.

The use of language and literary devices demonstrates discursive behavior since it continually evolves through many topics that have hidden meanings behind them. The explanation about the capacity reflects the discursive behavior, and the speech closes with the words "dream" and "inspiration," both of which contribute to the speech's plainly discursive nature. In the present study, the thematic and rhetorical characteristics of the vice chancellors' remarks are studied using critical discourse analysis (CDA).
